The difference between the standard rates (or the discounted rates if negotiated or eligible) and the amounts actually collected after all reasonable collection efforts have been exhausted is charged against the allowance for doubtful accounts.</p>

NMC's actions in these areas are tracked through normal operations rather than through the CHNA action plan which is focused on the top priorities. 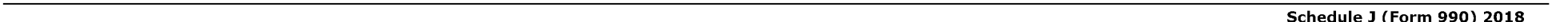
