In 2019, EDC's International Development Division developed its three year (2020-2022) strategic plan. The plan started as of October 1, 2019. EDC was awarded the Lebanon Higher Education for Capacity Development project by USAID/Lebanon. This project is working with institutions of higher education to better teach soft skills, better link curricula to labor market needs, and strengthen or establish university career centers. The Let's Read Zambia (LRZ) project is working to improve in-service teacher professional development relative to the teaching of early grade reading. The 2019 launch of LRZ was featured on the national news in Zambia. EDC's Work Ready Now (WRN) program was featured on Harvard's social and emotional learning website. WRN includes an updated module on social and emotional learning. The Global Book Alliance (GBAIA) project seeks to improve the supply of quality reading materials for children in a wide variety of languages. EDC representatives from GBAIA visited Malawi on a book supply chain analysis mission in late 2019.

U.S. Division: EDC's leadership of the Suicide Prevention Resource Center and the Zero Suicide Institute has helped improve outcomes for millions of people at risk of suicide. To date, over 70,000 practitioners have completed EDC's Assessing and Managing Suicide Risk training. Through Prevention Solutions@EDC, EDC addresses substance misuse nationwide. In 2019, EDC launched the Gambling Prevention Technical Assistance Center to tackle problem gambling. In the United States, EDC continued its innovative STEM education and workforce development work, including launching the Rural & Ready STEM initiative and leading 21 computer science education projects. EDC launched First 10 initiatives to close opportunity gaps for low-income children. In all 50 states and five territories, EDC helped home visitors, Head Start staff, and caregivers support children's health well-being, and school readiness. EDC continued to lead the Regional Educational Laboratory Northeast & Islands and also partnered with two other regional laboratories and two comprehensive centers. We seek grants and contracts from public-sector and private sponsors to carry out programs consistent with EDC's charitable and educational mission: to improve education, health promotion and care, workforce preparation, communication technologies, and civic engagement. Our services include research, training, educational materials and strategy, with activities ranging from seed projects to large-scale national and international initiatives. EDC issues subawards and grants to a wide variety of organizations to implement our overseas programs, including US and Non-US governmental organizations (NGOs), community based organizations, universities, and for-profit organizations. The capabilities of subawardees are examined by EDC either before it submits a proposal to its sponsor or post-award. Subawardees are approved in accordance with sponsors' requirements. For overseas grant programs that are implemented post award, EDC customizes a selection and evaluation RFA process that reflects the technical purpose of the subgrant program and the expected capacity of local recipients. Evaluation factors include a review of technical capacity, past performance, and financial/managerial capacity, as well as an evaluation of the programmatic proposal submitted by applicants. EDC Subgrants and Subcontracts are drafted by EDC's Office of Sponsored Programs, with the guidance of EDC's General Counsel as needed, and technical guidance from the EDC Project Director and local management staff. In some situations, local subgrants are drafted by EDC's field office staff using templates provided by EDC's Office of Sponsored Programs. These agreements contain detailed technical work statements, milestones, budgets, reporting requirements, audit requirements and any flow-down clauses, terms and conditions necessary to ensure that the subawards are carried out in a manner compliant with applicable federal, state, and local law and the terms of EDC's grants and contracts from its sponsors. Prior to issuing any subgrant, and pursuant to Executive Order 13224, EDC obtains a certification from prospective subgrantees that the recipient did not provide within the previous ten years, material support or resources to any individual or entity that commits, attempts to commit, advocated, facilitated, or participates in terrorist acts. EDC also confirms that the organization, official signatory, and key personnel are not listed on any of the major databases of persons and organizations linked with terrorism. The international grant agreements also contain specific provisions to protect against grant funds being used to support terrorist organizations or activities, to support or oppose any candidates for political office, for lobbying purposes, or in violation of any applicable laws. Payment provisions include cost reimbursement, advance and reconciliation and/or fixed amount awards paid upon achievement of milestones. Payments are regularly monitored to help ensure that significant grant amounts are not at risk for improper use or diversion. Technical and Financial monitoring of Subgrantees is accomplished in several ways and could include review of programmatic and financial reports, desk reviews, periodic site visits, and review of supporting documentation.

Performance by the subrecipient is monitored by the EDC Project Director, who is responsible for technical monitoring of subawards. The EDC Project Director is assisted by a financial manager to review and authorize payment of subrecipient invoices. For each subaward an appropriate monitoring plan is established, based on an assigned risk rating. The risk rating is based on information about the subrecipient's financial systems, gathered prior to issuing the subaward. The Project Director is required to periodically submit a subrecipient monitoring report to OSP, which is responsible for maintaining these reports.

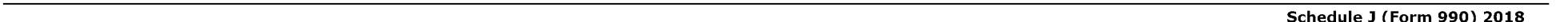
