The remaining board or committee members decide if a conflict of interest exists. A conflict of interest always exists when a voting member receives compensation directly from the corporation. If it is decided that a conflict of interest exists, the interested person may make a presentation at the board or committee meeting. After such presentation, he/she must leave the meeting during the discussion of, and the vote on, the transaction or arrangement that results in the conflict of interest. The chairperson of the board or committee then, if appropriate, appoints a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement. After exercising due diligence (at least 3 comparable quotes, if applicable), the board or committee determines whether the corporation can obtain a more advantageous transaction or arrangement with reasonable efforts from a person or entity that would not give rise to a conflict of interest. If a more advantageous transaction or arrangement is not reasonably attainable, the board or committee determines by a majority vote of the disinterested directors whether the transaction or arrangement is in the corporation's best interest and for its own benefit and whether the transaction is fair and reasonable to the corporation. The board or committee makes its decision as to whether to enter into the transaction or arrangement in conformity with such determination.
