THE FOUNDATION AND THE UNIVERSITY ENTERED INTO AN OPERATING AGREEMENT (THE AGREEMENT), WHICH GOVERNS THE GENERAL AND ADMINISTRATIVE AND DEVELOPMENT FINANCIAL RELATIONSHIPS BETWEEN THESE TWO ENTITIES. IN SUMMARY, THE AGREEMENT STATES THAT IN RETURN FOR CERTAIN SERVICES AND FACILITIES THAT ARE WITHIN THE CAPABILITY AND CONTROL OF THE UNIVERSITY, THE FOUNDATION WILL REIMBURSE THE UNIVERSITY FOR THE COST OF SUCH SERVICES AND FACILITIES. THE ACTUAL REIMBURSEMENT IS DETERMINED BASED ON THE ACTUAL COSTS INCURRED. IN ACCORDANCE WITH THE AGREEMENT FOR FISCAL YEAR 2019 AND 2018, PERSONNEL COSTS INCURRED BY THE UNIVERSITY AND CHARGED TO THE FOUNDATION WERE \$187,061 AND \$238,450, RESPECTIVELY.
