

**990-EZ Part I #10 Grants and similar amounts paid**

The majority of our spending goes directly to schools in Zimbabwe where we pay school fees and required expenses for 34 orphans and

vulnerable children. This fiscal year, we paid for 9 students to attend local day schools (\$12,400) 8 young adults to attend technical schools

(\$26,523), 9 students to attend boarding schools where we also covered their room board and transportation (\$41,638). We also

helped to pay for 8 students to attend college in Zimbabwe, South Africa or the United States (\$47,279). We cover medical fees

and provide supplementary nutrition as needed (\$5,220) and offer tutoring when needed and small incentives for high performing students (\$3,628).

Our additional expenses include travel to monitor programs (\$2,396), bank fees (\$606), taxes/filing fees (\$259), office supplies

and accounting (\$1,041), and website maintenance (\$212).
