If funds remain unexpended, the grant recipient is given a time period for spending the remaining funds for activities outlined in the original grant contract and then asked to submit another report at the end of that time period. If funds were expended for purposes outside of the grant contract, the grant recipient will be asked to either amend their agreement with Freshwater Future to a resolution acceptable to both organizations or if the funds were spent on a prohibited activity, the grant recipient will be asked to refund that portion of the grant award.
