TechConnect's NextUp West Virginia Program Funded by the U S Economic Development Administration and the Claude Worthington Benedum Foundation, the NextUp WV program (9/28/17 - 9/28/19) assisted 77 entrepreneurs and small businesses, created 46 jobs, retained 82 jobs, helped launched 19 new companies, and attracted \$2,226,000 in follow-on funding The project was delivered in partnership with three sub-awardees the Chemical Alliance Zone, the Center for Applied Research & Technology and the INNOVA Commercialization Group The project aimed to spur entrepreneurial and innovation activity, to help create and protect jobs in West Virginia, to expand access to capital, and to support West Virginia's continuing efforts to diversify its economy The NextUp WV program also offered training to more than 70 entrepreneurs and small businesses in how to pitch to angel investors during June and September of 2018 In addition, the NextUp WV program connects West Virginia's entrepreneur centers including incubators, accelerators, co-working spaces and makerspaces in order to share best practices in sustainable center management and guidance TechConnect mapped those centers in May 2019 and maintains that list on its website

TechConnect hosted forums and special events designed to raise awareness of the benefits of technology-based economic development, spotlight success stories and share best practices, and encourage innovation and entrepreneurship throughout the state. TechConnect hosted the Coding & Cyber Summit on November 15, 2018 (200 people). In January 2019, TechConnect published the West Virginia Cybersecurity Workforce Strategic Initiative Report, which outlined current educational programs in the state and included more than 20 recommendations for growing the industry sector. The Report was developed in collaboration with a wide group of stakeholders convened by TechConnect, including representatives of K-12 education and higher education (both 2-year and 4-year), the High Technology Foundation, West Virginia Forward and the West Virginia National Guard. By demonstrating the means of producing a tech talent pipeline, the state will be in a better position to attract or help start new technology companies (including those focused on cybersecurity) in the state. More than 100 individuals from education, higher education, private technology and other firms, government and pertinent nonprofit organizations have participated in quarterly meetings for this ongoing activity. In addition, TechConnect co-hosted Innovation & Entrepreneurship Day at the State Capitol on January 10, 2019 (95 people and 40 exhibitors) and the 2019 West Virginia Bioscience Summit (60 people). Events such as these are designed to spur cluster growth in key technology sectors.
