THIS YEAR, THE HYPE TEAM EXPANDED THEIR HEALTHY RETAIL PROGRAMMING BY WORKING WITH YOUTH-LED WELLNESS COUNCILS TO PROMOTE NEARBY FARMERS MARKETS AND HEALTHIER OPTIONS THAT ARE AVAILABLE AT THE CORNER STORE, AS WELL AS WORKING WITH PARTNERS TO HOLD IN-SCHOOL PRODUCE STANDS.

HEALTHY CORNER STORE INITIATIVE - TFT DEVELOPED THE HEALTHY CORNER STORE INITIATIVE (HCSI) IN 2004 TO INCREASE THE AVAILABILITY OF NUTRITIOUS FOOD IN UNDERSERVED NEIGHBORHOODS THAT LACK SUPERMARKETS OR OTHER FRESH-FOOD RETAILERS. 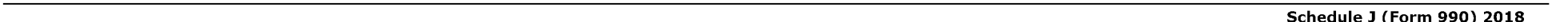
