If there are any changes in pay, a vote is undertaken by the board at the next available board meeting.

Part VIII, line 8c + 10b - Our accountant put our fundraising event (\$20,092) in with general contributions, and therefore we have no official fundraising revenue in our financial review, but we do officially have \$20,940 in expense. Similarly, we had \$7,115 in revenue for inventory but our expenses in this category are listed as \$10,556, which is skewed, because items we buy to donate fall under the umbrella of "micronutrient/child survival inventory", such as water filters. Therefore rather than display an inaccurate revenue total because of the extreme expense disparities, I wrote in "0" in line 8c and 10b. The final revenue total seen in line 12 of 243,157 is accurate as supplied to us by the accountant (\$236,040 in contributions, \$7,115 in inventory revenue, \$2 in investment income).
