


The Corridor is not a national park or a single site. It is comprised of many historically and culturally places of significance to the Gullah Geechee people. (Continued on Schedule O)

The Gullah Geechee people are the descendants of Central and West Africans who came from different ethnic and social groups. They were enslaved together on the isolated sea and barrier islands that span what is

now designated as the Gullah Geechee Cultural Heritage Corridor - a stretch of the U.S. coastline that extends from Pender County, North Carolina to St. John's County, Florida and for 30 miles inland.

The result was an intense interaction among Africans from different language groups in settings where enslaved Africans and their descendants formed the majority. Over time, they developed the creole Gullah Geechee language as a means of communicating with each other and they were also able to preserve many African practices in their language, arts, crafts and cuisine.

2019 ACCOMPLISHMENTS We convened a three-day, site study trip to better understand the work that is being done in Duval, Nassau and St. John's counties preserve and share Florida's Gullah Geechee heritage. Our planning partners included Ranger Ted Johnson (Timucuan Ecological and Historic Preserve) and Adrienne Burke (Director, Nassau County Planning + Code Enforcement). A day of roundtable-discussion at White Oak Conservation with institutional and community stakeholders was followed by two days in the historic communities of Cosmo, Armstrong, Mandarin and Edisto. The direct result has been a surge in programmatic activity in the state in the area of public education programs, identification of existing documentation and planned preservation and documentation partnerships. This project was funded by the GGCHC.

We were awarded \$95,000 in funding from the Gaylord & Dorothy Donnelly Foundation to use to hire outside consultants to help us design effective, land ownership preservation strategies for Gullah Geechee landowners and to develop a heritage tourism strategy for the Corridor.

This work will be completed in June 2020. Due to growing respect for the quality of our programmatic and technical assistance work, increased visibility and successful fundraising efforts, we were able to bring new revenue sources into our work from private philanthropy. This has led to a diversification of funding and temporary, capacity building with the hiring of grant-funded consultants. We have also seen a growing interest in donors willing to support our programmatic work.

We enhanced our presence last summer at multiple, Gullah Geechee heritage festivals by investing in a more robust travelling, educational tent with educational activities designed to educate about the agricultural history of the Gullah Geechee people. This programmatic activity was funded by the GGCHCC. We also were directly involved in helping to plan the 2019 Sweetgrass Basket Cultural Arts Festival in Mt. Pleasant SC which was being transitioned from a community-run festival into one facilitated by the town.

We increased the number of public educational programs we delivered on Gullah Geechee history and culture at sites across the Corridor. This work included the installation of a Gullah Geechee demonstration and teaching garden on Johns Island featuring Carolina Gold rice, indigo, okra and Sea Island Red Peas. These popular programs included a partnered series with the Charleston County public library on the history of indigo cultivation which included hands-on indigo dye workshops. This program has been extended by demand into 2020. The indigo program series was funded by the Charleston County Public Library and the GGCHCC. Seed and materials used in the Gullah Geechee demonstration garden were donated by the

CarolinaGold Foundation and other local, partners.

Pursuant to a Memorandum of Agreement between the U.S. Army Corps of Engineers, the Georgia Department of Transportation, Effingham County, the Georgia SHPO and the GGCHCC regarding GDOT PROJECT P. I. #0006700, an historical/archaeological rice field context will be developed that will be used to develop public information products which allow a greater understanding and appreciation of rice farming in the region, with specific interest in the role of enslaved Africans.

We are assisting the Charles Pinckney National Historic Site with the redesign of its visitors' center which will include enhanced interpretation of the lives of the people enslaved on Snee Farm. The project will be completed in FY 2021.

We also are advising on the interpretive work being done in connection with a newly discovered Gullah Geechee cemetery near the grounds of Fort Frederica National Monument. This will include installation of waysides and a public, memorial ceremony.

We are also collaborating with Cumberland Island National Seashore Park and researchers from the University of South Carolina on a two-year, research project to document the lives of the Gullah Geechee people who once lived on the island. This project includes an oral history component. Gullah Geechee Summer School: A multi-part, video conference series that provided a platform for sharing our primary interpretive themes with community members as well as professionals engaged in interpreting Gullah Geechee history at

national parks, heritage sites and museums. The series examined origins and early development of the Gullah Geechee people in the Low Country; their quest for freedom, equality, education and recognition; their connection with the land; traditional and contemporary cultural and spiritual expressions; and the unique Gullah Geechee language. The program also assists the public in understanding the Gullah Geechee Cultural Heritage Corridor and the work of the Commission. The program continues to draw more than 100 registrants each year.

Watch Night & Emancipation Proclamation Celebration: Over 50 churches and community sites actively participated in this program designed to re-invigorate the tradition of using the Watch Night, New Year's Eve church service to commemorate the date of January 1, 1863, when the Emancipation Proclamation went into effect. In support of this initiative, the Commission developed educational materials and documentary films to help educate the people about the history of this tradition and the Emancipation Proclamation. We conducted a daytime, Watch Night & Emancipation Celebration at Morris Brown A.M.E Church that included history talks and cultural performances designed to convey the importance of the Emancipation Proclamation to the Gullah Geechee people -- and how their Watch Night tradition helps keep alive their collective memory of what the dawning of freedom meant to their enslaved ancestors.

Gullah Geechee Documentary Film Festivals: The Commission acquired the rights (generally at no-cost) to screen classic documentaries on Gullah Geechee culture and history for the purposes of (a) providing a compelling teaching tool; and (2) creating a mobile program that local

communities could deploy at festivals and community meetings to interest and engage local audiences in their local work of Gullah Geechee heritage preservation. New, relevant films are continually added to the screening line-up. The Festival has been hosted by community festivals, local libraries, museums, churches and other community centers and has been viewed by more than 555 attendees throughout the four states within the Corridor.

Tracing Your Gullah Geechee Roots: Partnership with the Center for Family History at the International African-American Museum to offer free genealogy workshop including classes focused on mining the records of the U.S. Colored Troops and the Freedmen's Bureau.

Maroon Communities in South Carolina: Partnered program with Audubon SC to celebrate the resiliency of the Maroons. Maroon colonies, self-sufficient communities formed by enslaved who had liberated themselves, are widely-known in the Caribbean although they also existed in the Gullah Geechee Corridor, most famously in northern Florida.

The Weeping Time | 160th Commemoration On March 2 and 3, 1859, the largest slave sale in American history took place at the former Ten Broeck horse racecourse in west Savannah when 429 men, women, and children from the Butler plantations near Darien and St. Simons Island, Georgia, were sold. It rained torrentially stopping only after the last enslaved person was sold. Those who remembered called this tragic event the Weeping Time because, they say, God must have been crying. The people of West Savannah are the guardians of this poignant American history enshrined in their community and

on March 2, 2019, they placed 429 empty chairs on the site of The Weeping Time for a public memorial that drew visitors from across the region.

Brochure about the Gullah Geechee Cultural Heritage Corridor: We regularly print and distribute brochures about the Corridor to visitors' centers, heritage sites, and other sites where visitors seek information about learning opportunities in the Corridor.

Website: In FY 2019, we designed and launched a new website VisitGullahGeechee.com designed to serve as a portal for people seeking only information on places to visit and programs occurring across the Corridor. Until 2019, only the Gullah Geechee Cultural Heritage Corridor Commission had a website and there was no website for the Corridor itself. It also provided a platform for us to finally share a Corridor-wide event calendar which included events hosted by communities and third-parties.

OTHER PROGRAM INFORMATION LANGUAGE

Gullah is a unique creole language spoken along the Sea Islands and adjacent coastal areas of South Carolina and Georgia. The residents in Georgia are typically referred to as "Geechee." Gullah language began as a simplified form of communication among people of different languages including European slave traders, slave owners and diverse African ethnic groups. The vocabulary and grammatical roots come from European and African languages.

Gullah Geechee language is the only distinctly African creole language in the United States and has influenced traditional Southern vocabulary and speech patterns.

ARTS, CRAFTS AND MUSIC

Enslaved Africans brought a rich heritage of cultural traditions in art, food ways and music. Arts and crafts are the result of products designed by necessity for activities of subsistence and daily living such as making cast nets for fishing, basket weaving for agriculture and textile arts for clothing and warmth. The art of making casts for fishing has been passed down by enslaved Africans brought to the southeastern shores of the United States. Gullah Geechee people continue to use the nets to harvest

from the Sea Island waterways, but the tradition is labor intensive and artists are dwindling in numbers as younger generations have lost interest.

African textile traditions that included sewing strips of cloth into larger patterns were combined with European quilting methods and a creole art form emerged. Quilts with bright colors and designs were originally made for necessity. These traditions also allowed women a time for social interaction.

Sweetgrass baskets, originally designed for rice production and processing and other domestic uses in Africa, were used for agricultural purposes such as planting and harvesting of coastal crops. Made of bulrush, sweetgrass and split oak, the African art of basket making was significant as a traditionally passed down handicraft practiced by both men and women using similar materials from their homeland. Baskets also gained recognition for the skill of an artist and uniqueness in style. Even in historic times, baskets were sold to non-Gullah Geechee people and were a source of additional income.

African songs are the foundation for what may be referred to as Gullah music. Deeply rooted in music traditions brought to the Americas by enslaved Africans, the music evolved out of the conditions of slavery that characterized their lives. The influence and evolution of musical forms that arose out of Gullah music can be heard in many musical genres such as spirituals and gospel music, ragtime, rhythm and blues, soul, hip hop and jazz.

FOODWAYS Food has always played an important role in social traditions in many cultures. Gatherings, celebrations, and religious rituals, are often accompanied by food. The Gullah diet consisted of items available locally such as vegetables, fruits, game, seafood, livestock; items imported from Europe, items imported from Africa during the slave trade (okra, rice, yams, peas, hot peppers, peanuts, sesame "benne" seeds, sorghum and watermelon), and food introduced by Native Americans such as corn, squash, tomatoes and berries. Rice became a staple crop for both Gullah and whites in the southeastern coastal regions. Although a bounty of food types existed, there was not always a bounty of food available for enslaved Gullah people or their descendants. Making use of available food (rationing), making a little go a long way, supplementing with fish and game, leftovers from butchering and communal stews shared with neighbors were African cultural practices.

African cooking methods and seasonings were applied in the Gullah homes and plantation kitchens. Because plantation cooks were primarily enslaved women, many of the African cooking traditions were employed along with creatively incorporating foods introduced by European, Spanish and American Indian influence, much of the food today referred to as "Southern" comes from the creativity and labor of enslaved African cooks from the plantations.

SPIRITUAL EXPRESSION

Religion and spirituality have a sustaining role in Gullah family and community life. Enslaved Africans were exposed to Christian religious practices in a number of ways and incorporated elements that

weremeaningful to them into their African rooted system of beliefs. These values included belief in a God, community above individuality, respect forelders, kinship bonds and ancestors; respect for nature, and honoring thecontinuity of life and the afterlife. Some plantation owners had regularreligious services on the plantation and required slaves to attend. Someplantations had separate services for blacks with black preachers.

Plantations frequently had a praise house or small structure where slavescould meet for religious services, but these also had significance inmaintaining community cohesion, social structure and conflict resolution.
