FY 2019 activities demonstrate the ongoing capacity of Capital for Good USA (CFG) to meet donors needs to connect their funding with strong partners. The Girls First Fund launched its initial grants to six different countries and 150 different organizations during the year. Throughout the Girls First Funds second fiscal year (October 1, 2018 September 30, 2019), a team was established, foundational values and guiding principles defined, and a successful implementation of an ambitious workplan to select an inaugural cohort of 150 grantees was achieved. With the start of the Learning Year in May 2019, we focused on learning from and with grantees about how child marriage and early unions occur in grantee communities and what has been successful in addressing this human rights violation. These learnings will inform discussions throughout 2020 on the funds identity, multi-year strategies, global grantmaking expansion, and MEL strategies. With these efforts, the funds goal remains central - to contribute to the growth and development of thriving, well-supported, and connected community-based organizations (CBOs) and movements, prioritizing those led by girls and women, who are working holistically to transform gender norms; build girls power, voice and choice; hold those in power to account; and, build solidarity across communities and borders. Objectives for the fund are to increase donor collaboration in the sector, radically expand resources to community based organizations and support locally relevant and effective strategies. Other donors to Capital for Good have provided funding for out of school children programs in Ethiopia and Uganda. In Ethiopia the CFG funding is directed at five grantees who are operating 170 Speed School classes and serving 5,100 students and 5,100 mothers. 57 government primary schools are link schools which are expected to receive Speed School students after completing the 2018-2019 academic year. These link schools are being supported through capacity building activities including training, education communities of practice, and small school grants for early warning system to prevent school dropout. 96% of the CFG students successfully completed the school year and 98% of these students transitioned to the government schools. June of 2019 saw the completion of the Speed School programs eighth year in Ethiopia. Since its launch in 2011/12, the program has evolved in many ways. The core model and methods have changed and added certain elements, aiming to sharpen qualitatively pretty much every pedagogic and other operational dimension. The programs geographic scope has expanded, beginning in just one region, the Southern Nations, Nationalities, and Peoples Region (SNNPR) and now partnering with all four of the countrys largest regions, adding Tigray in 2013/14, Oromia in 2014/15, and Amhara in 2015/16. Other regions are communicating their eagerness to implement the model and the program has attracted new funding partners including interest from national and international organizations. Lastly, and perhaps most promising, both the federal and decentralized governments of Ethiopia have begun in earnest the process of adopting the Speed School model, creating the foundation for the programs sustained and scaled implementation. We envisage this process to take up to five years. During the 2018/19 Speed School year, total funding (of which Capital for Good is one of the funders) program reached 51,116 total direct beneficiaries, spread across the four key components: Speed School classes; the Self-Help Groups; the Primary School Capacity-Strengthening activity; and the Child-to-Child pre-school program. Indicative of the significant progress in government adoption was the fact that three of the four regions funded and operated their own Speed School classes called Accelerated Learning Program (ALP) classes and that the number of ALP classes nearly tripled this year from last. (The fourth region, Amhara, joined the group, funding ALP classes in 2019/20.) Speed Schools in Uganda run from February through December. Another donor provided funds for 24 Speed Schools in Uganda through one grantee partner. These funds supported 1,968 unique beneficiaries including Speed School learners, facilitators, SHG parents, pre-school children, ECD caregivers and trained link schoolteachers. 70% of these students qualified for grade 4 at the end of the one year program (December 2018) and overall 95% of the students qualified for placement in the government schools. Additional funding to the Uganda program through CFG continues during the 2019-2020 academic year. CFG is the fiscal sponsor for Financing Alliance for Health (FAH). This organization aims to help governments design and fund ambitious, highly effective, affordable and at-scale health systems. This project is focusing on health systems at the community level within Africa. FAH's main in-country "services" include system design support (overall community health plan design, developing and costing an integrated community health plan, model refinement, and targeted technical support) and financing support (resource mapping, return-on-investment analyses, financing strategy, developing alternative financing and fiscal scenarios, and advising on options). During 2019 FAH provided continued support to several countries. Investment case work for Zambia is in finalization. In Zimbabwe, the draft community health strategy and health package is complete: next steps are implementation plan and investment case under the UNICEF PCA. Mali and Kenya will be phased in early 2020 with potential to collaborate with Integrate Health and AMP Health in Togo in later part of 2020. FAH is in the process of contracting with Last Mile Health Community Health Academy (LMH CHA) for the development of an online course on community health financing to be potentially deployed on HarvardEX platform. CFG provides CSR services to Geneva Global. During 2018-2019 there were a number of grantees selected to receive this funding which included: - VNA Philadelphia provides care to approximately 1,200 patients annually through home health, palliative and hospice programs combined. The oldest home health care agency in the region, VNA Philadelphia has been a leader in community health since 1886. Between October 2018 and October 2019, 172 patients utilized this "Free Care" allowing it to continue its mission. - Nationalities Service Center received a general operating support grant. That allowed this organization to develop, among other initiatives, a FY20-22 Strategic Plan, which lays out strategies to build a strong, sustainable organization that is capable of not only surviving but thriving in these unprecedented times. It aims to do this by strengthening the agency from within, with the addition of an HR department; by being attentive to clients' needs and feedback; by improving and streamlining its data collecting methods; and by expanding and broadening its programs to offer its clients the most needed services. - The grant to Saint John of God Hospital Services of Malawi helped improve the quality of life of children with intellectual and physical disabilities and that of their parents and guardians in Mzuzu through promoting early interventions services, advocacy, special needs education and pre-vocational interventions, postural management, sporting and recreational activities for children with disabilities including counselling and skills building for parents. In total, 503 children benefited from the various activities implemented under this project. Of these 298 males, 205 were females. Specifically, 84 children accessed educational activities from its SJOG Elvira Institute of Special Needs while 62 children benefited from portage/ early intervention services. In addition, 228 children were assessed and treated of various physical and mental health conditions and 42 children were beneficiaries of postural management equipment. The project has 21 children benefitting from nutrition support to address the nutritional needs of malnourished children, 25 children benefited from the respite care an intervention for children with severe to profound disabilities and 40 children benefited from physiotherapy through its Pisa Physiotherapy Centre. - Broad Street Ministries grant, also a general operating support grant, helped it advance its proven programming for vulnerable Philadelphians, objectives of which include: The individuals served have improved physical health; the individuals served have improved psychological health; and the individuals served move towards a more stabilized status. In pursuit of its objectives, the Hospitality Collaborative (HC) provided nutritious meals served in an indoor, family style setting to an average 254 adults per meal in 2018. Its trauma-informed model of care was employed to mitigate the traumatic effects of living with chronic scarcity: it delivered its serv
