Publishing - Each year, Mission Eurasia prints specially designed Scripture pieces in Russian, Ukrainian, and other national languages, along with distributing hundreds of thousands of copies of these pieces throughout Eurasia. In 2018-2019, Mission Eurasia's SWW students and other national Christian leaders distributed 1,025,800 copies of the following Scripture pieces throughout Eurasia: Evangelistic calendars, New Testaments, Light magazine, Spark magazine, Bold Hope, and the Gospel of Luke. In addition, Mission Eurasia is helping to cultivate a Next Generation of Christian authors within Eurasia through its National Christian Authors Series. Through this program, Mission Eurasia oversees the publication and distribution of titles that enable young leaders to present solutions to the challenges facing the evangelical church and society in Eurasia. These titles are then used in our SWW leadership-training program, conferences, and pastoral training seminars.

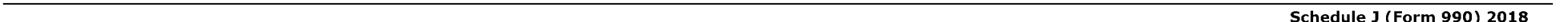
