Providing free food to the needy in our area both on a walk-in basis (to our food pantry, open two days per week) and via delivery to those unable to pick up. The total value of food provided (estimated) is \$145,690 which includes \$14,208 purchased with our cash donations and \$131,482 of in-kind donations from local food banks, retailers, our own parishioners, and others. This food was provided to 2479 households containing 7017 individuals. We received no revenue from this activity.

4b (Code:) (Expenses \$ 69,400 including grants of \$ 0) (Revenue \$ 0)

Providing new and used clothing and housewares to those in need in our area, primarily by those individuals selecting items from our Center while the food pantry is open, plus special distributions and deliveries. The total value of items given (estimated) is \$69,400, all of which comes from in-kind donations. These items went to 3508 people. We received no revenue from this activity.

4c (Code:) (Expenses \$ 46,639 including grants of \$ 0) (Revenue \$ 0)

Providing emergency financial assistance to those in need in our area, for such items as payments to avoid utility shut-off, payments to avoid rental eviction, transportation aid (such as bus tokens), medical bills, and similar needs. This help was provided to 684 people. All funds for this activity come from donations provided by our Church congregation and other individuals. No revenue was received for this activity.

Part I Line 2 As we are an organization dedicated to serving those in need, all monetary grants and in-kind distributions are made to individuals who indicate financial need, primarily in compliance with attestations of income levels required by local food banks and similar organizations. Clients must also provide evidence of residence as, per our by-laws, we primarily serve those in our Parish area. Monetary grants (emergency financial assistance) are typically provided only to avoid utility shut-off, rental eviction, and similar situations. Any such cash grants are paid directly to the utility provider, landlord, or transport or medical provider after verification with that provider. We do not give cash or checks to clients, thereby providing a safeguard that funds are used as intended. Records of our financial and food assistance are maintained as paper and on-line documents at our facility, are kept on forms required by our local food banks and other providers, and are updated at visit by, or to, a client. Our practices significantly limit the amount of assistance any one client can receive as well as limiting the times they can re-apply for further assistance. Therefore no individual client received aid in excess of \$2000 total within the year.

Part III column (b) Line 1 (food distribution) recipients number is taken directly from the total household numbers reported and signed for by our clients at each time of distribution, either in our pantry or delivered. Line 2 (clothing) recipients are estimated at one-half the food number based upon ongoing observation and discussion with use receiving clothes and goods.

Line 3 (financial assistance) recipients number is based directly upon our outlays for those services
