Trainees complete evaluation forms, which are used to report on the training course's effectiveness to the entity funding the training. The Association provides subawards to organizations to assist in performing trainings under federal grants. The Association follows federal regulatory guidelines for monitoring the use of grant funds. It qualifies prospective subawardees by checking the system for award management to ensure that prospective subawardees are not suspended or debarred, and by checking the Federal Audit Clearinghouse to confirm prospective subawardees have submitted single audit reports. It assesses the risk of non-compliance as required by 2 CFR 200.331 (B) (1) through (4), determines the level of subrecipient monitoring required, and prepares a monitoring plan. The Association negotiates a budget and a scope of work with prospective subawardees and includes the subawardee budget in the grant proposal it submits to the funding agency. Once a grant is awarded, the Association negotiates a subaward containing the scope of work and budget, reporting and invoicing requirements, and procedures for monitoring as required by the assessed risk of non-compliance. The Association requires subawardees to submit invoices and progress reports, which it compares to budgets and project deliverables to make sure expenditures are within budget and program deliverables are of acceptable quality and are delivered on time.
