The Winona Health Foundation assists Winona Health in achieving its mission to improve the health and well-being of its family, friends and neighbors. The geographic scope is the City of Winona and surrounding communities in Minnesota and Wisconsin. The Foundation makes grants and contributions to Winona Health's nonprofit affiliates including Winona Health Services and Winona Senior Services. Winona Health Services includes a 49-bed primary care hospital that also includes an emergency department, provides inpatient mental health services, rehabilitative and dialysis services, outpatient diagnostics and ambulatory surgery. (Continued on Schedule O) It also includes primary care clinics in Winona and Rushford, Minnesota, and specialty clinics including sports and orthopedic specialists, eye care center, pain management center, psychiatric and counseling services, occupational health, durable medical equipment, retail pharmacy and urgent care clinic. Winona Senior Services includes Lake Winona Manor, a 110-bed skilled nursing facility, Adith Miller and Roger Metz Manors, 20-bed assisted living facilities for memory care, Watkins Manor an assisted living facility for 59 seniors, and hospice services. In the mid-80s, Benjamin A. Miller, a former Winona-area businessman and philanthropist, established the Ben & Adith Miller Patient Care Fund in the Winona Health Foundation in honor of his wife, Adith. The Ben & Adith Miller Patient Care Fund is a unique community resource that helps individuals and families pay for unexpected medical expenses incurred while seeking care at Winona Health. In FY2019, the fund helped 791 families pay more than \$1,005,760 in medical bills.

Winona Health Foundation fails to meet the public support test for the years ended September 30, 2013 through September 30, 2019. However, based on the following facts and circumstances, the organization should continue to be recognized as a publicly supported organization under Internal Revenue Code Section 509(A)(1) Ten-Percent of Support. The total amount of public support for the organization during the above mentioned period is 30.79%. Therefore, the total public support is greater than the required 10% Attraction of Public Support. The organization does not receive more than 33 1/3% of its support from government units or from contributions from the general public due to the fact that it has received some substantial donations from local corporations and individuals. The organization uses several methods to attract support from the general public. Some of these methods include an annual fundraising event, advertising for memorials at annual community events, community-wide direct mailings, personal visits during patient stays at affiliated healthcare facilities, and online solicitations via the organization's website. Sources of Support Winona Health Foundation does not receive support from a single family, rather it receives support from members of the general public. The organization received a portion of its support from individuals in the community. The number of unique donors who have made contributions to the organization each fiscal year are as follows: FY2019 1,431; FY2018 1,293; FY2017 1,950; FY2016 1,651; FY2015 1,942. The Foundation receives a significant amount of its total support from investment income which impacts the percentage from contributions. Representative Governing Body Winona Health Foundation is served by a governing body that represents the interest of the public; it does not represent the interests of a limited number of donors of Winona Health Foundation. These representatives ensure that the organization meets the needs of the healthcare community. Based on the above facts and circumstances, Winona Health Foundation should continue to be considered as publicly supported under Internal Revenue Code Section 509(A)(1).

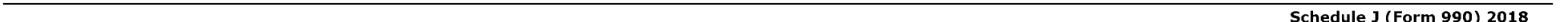
