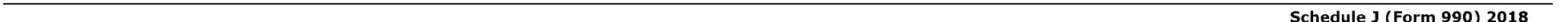

All business lines performed by Alphapointe involve blind labor. The commercial business is primarily occurring within the plastic manufacturing, sewing and call center operations, adding at least 10 incremental employment opportunities for blind workers. The agency provides comprehensive rehabilitation, education and activities for all ages of people who are blind and visually impaired during the Fiscal year, we served 2,219 individuals. Alphapointe's comprehensive services include personalized instruction in braille, adaptive technology, orientation and mobility, daily living skills, diabetes education, college prep, and job placement services provided to 793 people. Senior adult services were provided occupational therapy and devices at Alphapointe or in their homes, for a total of 116 seniors. A low vision clinic provided services to 295 individuals. A total of 362 children and youth participated in adventure and technology camps, and ongoing youth development education and programming. Another 653 individuals received referrals, guidance and educational programs regarding their vision loss. The agency received 11,018 hours of volunteer services for those being served by Alphapointe.</p>
