**Part I, line 10, grants and similar amounts paid of \$15,814 has one grantee that exceeded \$5,000, which was Oral Roberts University (7777 South Lewis Avenue, Tulsa, Oklahoma, 74171), for \$6,000, in appreciation of their support in our recruiting volunteer English teachers, as noted in one of our three largest program services in Part III of 990-EZ. The grant helps support Oral Roberts University in assisting their students to serve as volunteers in China. This grantee has no reportable relationship.**
