**PART 3 - ORGANIZATION'S PRIMARY EXEMPT PURPOSE:**

Lexington Area United Way is a community-supported organization which invests donor dollars in the areas of greatest need in the community. This is achieved by a network of community volunteers who, in coordination with the Executive Director, determine what the greatest needs are and the most effective manner possible to invest dollars to ensure positive results in the service area
