MAJOR DECISIONS AND FINANCIAL EXPENDITURES ARE ESCALATED TO THE BOARD FOR CONSIDERATION. OTHER DAY-TO-DAY DECISIONS ARE MADE BY THE PROPERTY MANAGER AND COMMITTEE. THIS PROPERTY MANAGEMENT OVERSIGHT COMMITTEE REGULARLY REVIEWS THE PERFORMANCE OF THE PROPERTY MANAGEMENT COMPANY. IN 2017, THEY RECOMMENDED TO THE BOARD OF DIRECTORS TO RENEW THE CONTRACT WITHOUT MODIFICATION FOR ANOTHER THREE YEAR PERIOD. THE BOARD OF DIRECTORS APPROVED RENEWAL BY VOTE.

AS SUCH, REFERENCES TO THE FEDERAL HOUSING COMMISSION AND NATIONAL HOUSING ACT REQUIREMENTS WERE DELETED FROM THE ARTICLES OF INCORPORATION, AS THEY ARE NO LONGER APPLICABLE TO THE OPERATION OF THE ORGANIZATION. A SUMMARY OF AMENDMENTS TO THE ARTICLES OF INCORPORATION ARE AS FOLLOWS: 1) ARTICLE II, PURPOSE OF THE CORPORATION, WAS AMENDED TO DELETE REFERENCE TO PROVIDING HOUSING FOR FAMILIES DISPLACED FROM URBAN RENEWAL AREAS OR AS A RESULT OF GOVERNMENTAL ACTION, WHICH WAS A PROVISION OF THE FEDERAL HOUSING COMMISSION. THE ORIGINAL STATED PURPOSE REMAINS AS PROVIDING, ON A NONPROFIT BASIS, HOUSING FOR LOW- AND MODERATE-INCOME FAMILIES. 2) ARTICLE III, CORPORATION POWERS, WAS AMENDED TO DELETE REFERENCE TO EXECUTION OF A REGULATORY AGREEMENT IN ACCORDANCE WITH THE FEDERAL HOUSING COMMISSION'S NATIONAL HOUSING ACT. IT IS ALSO AMENDED FOR DISSOLUTION PROVISIONS. THE ORGANIZATION DELETED REFERENCE OF CONVEYANCE OF PROPERTY TO THE FEDERAL HOUSING COMMISSIONER, AND ADDED THAT UPON DISSOLUTION ALL REMAINING ASSETS SHALL BE CONVEYED OR DISTRIBUTED ONLY TO ST. PAUL LUTHERAN CHURCH OF LEAVENWORTH. 3) ARTICLE IV, REGARDING BOARD MEMBERSHIP QUALIFICATIONS, AMENDMENTS STATE THAT MEMBERSHIP IS LIMITED TO INDIVIDUALS WHO ARE VOTING MEMBERS OF ST. PAUL LUTHERAN CHURCH OF LEAVENWORTH. THIS UPDATES THE CURRENT NAME OF THE CHURCH AS WELL AS REFLECTS THE CURRENT OPERATION OF THE CHURCH TO A VOTING MEMBERSHIP CONGREGATION. 4) ARTICLE V, PROVISIONS OF BY-LAWS ADOPTION, WAS AMENDED BY DELETING REFERENCE TO THE REGULATORY AGREEMENT WITH THE FEDERAL HOUSING COMMISSIONER, AND BY ADDING THE STATEMENT, "THE FACT THAT SUCH POWER HAS BEEN SO CONFERRED UPON THE DIRECTORS SHALL NOT DIVEST THE MEMBERS OF THE POWER, NOR LIMIT THEIR POWER, TO ADOPT, AMEND OR REPEAL BYLAWS." 5) ARTICLE VI, PROVIDING THE ARTICLES OF INCORPORATION AND ANY SUBSEQUENT AMENDMENTS BE APPROVED BY THE FEDERAL HOUSING COMMISSIONER, WAS DELETED. AT THE SAME TIME, THE BOARD OF DIRECTORS OF THE ORGANIZATION ADOPTED BYLAWS THAT REFLECT THE TRADITIONAL OPERATION OF THE ORGANIZATION AND INCORPORATES CHANGES IN THE ARTICLES OF INCORPORATION AS PREVIOUSLY DESCRIBED.
