(LID Center) is a non-profit 501(c)(3) national research organization that focuses on sustainable stormwater management solutions for urban and developing areas. A key program area of the LID Center is focused on the integration of LID and sustainable green technologies into transportation projects

 The LID Center is under a multi-year contract to assist Prince George's County, MD with stormwater goals. This includes partnering and hiring other NGOs, contractors, and consultants that are based in PG County to participate in projects and gain capacity on LID approaches. The five project areas are: 1) Municipal NPDES Phase II Support and Reporting; 2) Municipal and County NPDES Property Management and Maintenance, SWPP Support; 3) Green Contractor Training - Public Participation and Education; 4) Technical Planning, Design Project Management & Outreach Support; and 5) Grant Management Services

4b (Code) (Expenses \$ 238,059 including grants of \$) (Revenue \$ 373,711)
 Through this contract, the LID Center is developing programmatic approaches and supporting research for the first stormwater public and private partnership in the nation. The objective of the program is to develop a national model on the approach. The work includes economic assessments and research, development of jobs programs, and innovative approaches for planning and design for the implementation of stormwater compliance controls

4c (Code) (Expenses \$ 119,776 including grants of \$) (Revenue \$ 115,727)
 This project's purpose is to evaluate the use of enhanced micro-bioretenion to support Prince George's County's and the Clean Water Partnership's efforts to reduce the retrofit of uncontrolled urban development. The project includes twelve project sites: five from the County's Alternative Compliance Program (ACP), one project located in a residential neighborhood, four schools, and two park sites. Seven of the twelve sites have been constructed, and one is under construction. The remaining four are scheduled to start construction by this winter. An automated monitoring station has been installed at the residential site to measure flows for TSS, phosphorous, and nitrogen loads entering the facilities and then discharged to the storm sewers after being filtered by the high-flow media and a Water Treatment Residual Mix
