The Foundation Grants Program begins with the application process including a series of detailed questions and a line item budget. Applications are first reviewed by the Foundation Board Review Committee and rated based on strategic relevance and need. The Committee's selections are prepared for the Foundation Board of Directors who select the programs that will receive funding. Applicants are invited to attend a Board meeting where they present their projects to the Board, from conception to completion. Grants are selected and awarded for the accomplishment of a definite purpose directly impacting the Clinic's operations within a specified time period. Each Grant recipient receives a Letter of Agreement (LOA) containing extensive details covering every aspect of the Grant. The LOA also states that each recipient is required to submit three progress reports at different intervals during the year. The LOA is signed by the Grant recipient and the recipient's department Vice President or Chair and returned to the Foundation. All expenses associated with the Grant must be approved by the Foundation's Chief Development Officer (CDO) and paid by invoice through the Foundation. All expenditures are tracked and recorded by line item and held within the Foundation.
