The tax benefit from an uncertain tax position is only recognized in the consolidated balance sheets if the tax position is more likely than not to be sustained upon examination, based on the technical merits of the position. Interest and penalties, if any, are included in tax expense in the consolidated statements of revenue, costs, and changes in Institute net assets. As of September 30, 2019, and 2018, the Institute had no uncertain tax positions that qualify for recognition or disclosure in the consolidated financial statements.</p>
