SHELTER SERVICES - During our fiscal year which ended September 30, 2019, the Atlanta Humane Society provided essential care for nearly 18,000 animals both in the Atlanta Metro and across the Southeast. For these animals who came into our care, Atlanta Humane performed 24,000 medical procedures, 13,000 spay/neuter surgeries, and 1,500 behavior and obedience trainings. Pet overpopulation and homelessness continues to overwhelm communities across the Southeast. Over the past year, we rescued, rehabilitated, and rehomed nearly 11,000 animals. As an important part of our mission work, our animal protection unit worked with local law enforcement and animal controls to save over 250 animals from cruel or neglectful situations this year.

VETERINARY CENTER - Atlanta Humane Society operates a full-service veterinary hospital providing high-quality, affordable care for pets in Atlanta. The staff and veterinarians believe in educating pet owners about the importance and accessibility of preventative care and routine wellness exams. The practice provided 3,790 affordable medical visits for 2,250 animals throughout the fiscal year ended September 30, 2019.
