



Twenty-two parish conferences located in central and southern Alabama provided person-to-person assistance to impoverished members of the community. Conference members visited those in need, offering direct assistance in many forms, including food, utility payments, rent or mortgage assistance, prescriptions, or simply listening with compassion and offering prayers. 23,734 people were helped during 11,016 visits; in-kind services valued at \$12,590 were rendered in 131 instances; and, goods valued at \$266,260 were provided in 3,805 instances. Conference members devoted 35,646 hours of service, logging 75,665 estimated miles.

The District Council supported the conference members who serve the poor with training workshops, retreats and materials, conducting an Ozanam Orientation with 35 members in attendance.

The conferences and District Council supported the National Council of the United States and the Council General International of the Society of St. Vincent de Paul by adhering to the Rule, regulations, guidelines and directives promulgated by, and by providing financial support to those authorities.
