Grand Teton National Park Foundation (the Foundation) is a private, nonprofit organization whose mission is to fund projects and programs that preserve and enhance Grand Teton National Parks cultural, historic, and natural resources and to help others learn about, experience, and protect the Park. Budget limitations, combined with increasing visitation, led the National Park Service to create partnerships with organizations like the Foundation to raise private money for special park needs. The Foundation facilitated the multimillion-dollar Craig Thomas Discovery and Visitor Center, a public-private facility that opened in 2007, and privately funded a 150-seat high-definition auditorium addition that opened in April 2011. Private gifts also support ongoing commitments in the park each year as well as one-time projects that improve the park, the visitor experience, and advance the organizations mission.
