ANY DIRECTOR, OFFICER, OR MEMBER OF A COMMITTEE WITH BOARD-DESIGNATED POWERS WHO HAS A DIRECT OR INDIRECT FINANCIAL INTEREST IN AN ITEM ON THE AGENDA THAT REQUIRES BOARD APPROVAL, IS NO LONGER CONSIDERED INDEPENDENT AND IS REQUIRED TO DECLARE SUCH CONFLICT EITHER IN WRITING TO THE CHAIR OF THE BOARD PRIOR TO THE MEETING OR VERBALLY DURING THE MEETING. DIRECTORS WITH A MATERIAL CONFLICT OF INTEREST SHOULD RECUSE THEMSELVES FROM ALL BOARD DISCUSSIONS AND VOTES ON THE MATTER. THE DISCLOSURE OF THE CONFLICT IS DOCUMENTED IN THE MEETING MINUTES. EACH DIRECTOR COMPLETES A CONFLICT OF INTEREST QUESTIONNAIRE UPON THE INITIAL COMMENCEMENT OF SERVICE OF A DIRECTOR, OFFICER, OR MEMBER OF A COMMITTEE WITH BOARD-DELEGATED POWERS, THEN ANNUALLY THEREAFTER AT THE END OF EACH FISCAL YEAR.
