WE ALSO APPLIED FOR TAX EXEMPTION WITH THE IRS. DCSC NEGOTIATED AND ENTERED INTO A CONTRACT WITH THE CITY OF DENVER AS REQUIRED BY THE ORDINANCE, SECURING OVER \$8,000,000 IN GRANT REVENUE. WE ESTABLISHED A WEBSITE, HELD MONTHLY BOARD MEETINGS, AND CONDUCTED OUTREACH TO APPROXIMATELY 100 ORGANIZATIONS THAT COULD RECEIVE GRANTS FROM THIS PROGRAM.
