Scholarships are granted based on objective criteria such as academic excellence and financial need without regard to race, ethnicity, gender, gender identity or religious affiliation. The Foundation awarded scholarships to 24 students in amounts ranging from \$1,000 to \$3,700 during this tax year.

Youth Services - Resources and volunteer hours are given to a variety of groups delivering educational, recreational and cultural opportunities to youth. Examples of projects and groups supported are early learning programs, summer reading programs, outdoor education for 5th graders, Boys and Girls Club activities, and school robotics programs.
