ARCUS envisions strong and productive linkages among international Arctic researchers, educators, communities, and other stakeholders that promote discovery and understanding of the Arctic and inform sound decisions related to the Arctic.

ARCTIC LOGISTICS AND COMMUNITY SCIENCE PLANNING: These activities coordinate and support Arctic research across disciplinary, organizational, sector, cultural, and geographic boundaries. ARCUS is the Project Office for the Study of Environmental Arctic Change (SEARCH), which is a collaborative program that advances research, synthesizes research findings, and broadly communicates the results to support informed decision-making. SEARCH has produced short briefs, available online, that summarize Arctic science topics for decision-makers, and organized a conference in 2019 of Arctic scientists, Indigenous Peoples, and policy makers to jointly explore the knowledge needed to inform decisions concerning the Arctic in coming decades. ARCUS also works with the U.S. Interagency Arctic Research Policy Committee (IARPC), providing operational support and bringing research community perspectives to inform the U.S. government's Arctic Research Plan. In addition, a highly-rated seminar/webinar series brings Arctic experts to a broader community by providing open, online seminars on a variety of topics.

OUTREACH AND INFORMATION: ARCUS provides valuable information about a wide range of Arctic research efforts through a variety of outreach tools. Key activities include the ArcticInfo email list (with over 5,000 subscribers), the global Directory of Arctic Researchers and Calendar of Arctic Research Events, the Witness the Arctic Newsletters (with over 8,800 subscribers), a Conducting Research with Northern Communities web resource, and hosting students with the Alaska Native Science and Engineering Program. In the education arena, the PolarTREC program supports the development of outstanding educators by placing and supporting them as part of a Polar research team. The Arctic in the Classroom project connects rural Alaska teachers with researchers working in their communities to engage students and residents in the research projects that affect them. The Sea Ice for Walrus Outlook is a collaboration between coastal Arctic Alaska communities, the National Weather Service, and other scientists to provide forecasts and on-the-ground information about local conditions to enable safe subsistence activities.

CORE SUPPORT: Core support is funding of tasks and resources that simultaneously support multiple projects. Core support includes the technological, website, and management infrastructure that supports information and outreach, networking, and other communications tasks across the disciplinary, organizational, sector, cultural, and geographic boundaries of Arctic research. For example, core support would include a reader survey that informs several communication tools (e.g., ARCUS newsletters, email lists).

The Sea Ice Prediction Network is a program to improve Arctic sea ice forecasts using a multi-disciplinary approach that includes modeling, new products, data analysis, scientific networks, stakeholder engagement, and open webinars and workshops. ARCUS provides essential planning, project management, and communications expertise for the large interdisciplinary Sea Ice Prediction Network, which comprises scientists and users of sea ice information. ARCUS also convened a Polar Technology Conference to provide recommendations for technological innovations for polar field research.
