EVENTS INCLUDE FIELD TRIPS, COMMUNITY AND ENVIRONMENTAL SERVICE PROJECTS, AND EDUCATIONAL PROGRAMS SUCH AS STEM (SCIENCE, TECHNOLOGY, ENGINEERING, MATHEMATICS) PROGRAMS. GIRL SCOUTS OF ALASKA'S LARGEST EVENT IS WOMEN OF SCIENCE, WHERE WOMEN IN DIFFERENT SCIENCE CAREERS PRESENT AND TALK WITH GIRL SCOUTS ABOUT THEIR FIELDS OF WORK. THE COOKIE AND NUT & CANDY PROGRAMS TEACH GIRLS BUSINESS SKILLS INCLUDING GOAL-SETTING, PUBLIC SPEAKING, AND MONEY MANAGEMENT. THE COOKIE PROGRAM ALLOWS GIRLS, TROOPS, AND SERVICE UNITS TO EARN RECOGNITION AND REWARDS THAT THEY CAN USE TO PAY FOR GIRL SCOUT PROGRAMS OR CAMPS. 1664 GIRLS PARTICIPATED IN THE COOKIE

CAMPS: GIRLS CAN PARTICIPATE IN GIRL SCOUTS BY ATTENDING SUMMER CAMPS. GIRL SCOUTS OF ALASKA PROVIDES RESIDENT AND DAY CAMPS THROUGHOUT SOUTHERN ALASKA. CAMP IS ONE OF THE HIGHLIGHTS OF BEING A GIRL SCOUT AND PROVIDES MEMORIES FOR A LIFETIME. THIS YEAR, 2,229 GIRLS ATTENDED DAY CAMP AND 584 GIRLS ATTENDED RESIDENT CAMPS. CAMP TOGOWOODS IN WASILLA AND CAMP SINGING HILLS IN CHUGIAK ARE AVAILABLE TO TROOPS THROUGHOUT THE YEAR FOR TROOP CAMPING ACTIVITIES.

WE HAD 1,456 REGISTERED ADULTS THIS YEAR. MOST OF THE GIRLS PARTICIPATE BY JOINING A TROOP. VOLUNTEERS WORK WITH THE ASSISTANCE OF GIRL SCOUTS OF ALASKA TO ORGANIZE TROOPS, RECRUIT VOLUNTEER TROOP LEADERS, AND TO SUPPORT THE VOLUNTEER STRUCTURE.
