InspirASIAN distributed \$188,677 in scholarships, including \$1,000 and \$2,000 scholarships to 98 graduating high school seniors who have been accepted to accredited universities. Students applied online, submitted their transcripts, sent a letter of recommendation, wrote an essay on a topic we provided, and showed their leadership skills through volunteerism at school and the community. We received in excess of 600 applications from students throughout the U.S. Each submission was reviewed by a panel of judges and tabulated based on their GPA, letter of recommendation, essay, volunteers hours, and leadership skills. The top 21 students each received a \$2,000 scholarship from the National Scholarship Program. The next tier of students were sent to the local chapters, who awarded another 77 students \$1,000 each. Additional scholarships were also awarded to undergraduate and graduate school students studying in under-represented fields such as art and political science and needy high school students. InspirASIAN works with local high school counselors to help distribute the InspirASIAN Scholarship information. The program is available to all students regardless of race. We are proud to be able to distribute the scholarships to the students based on their needs and accomplishments. Local InspirASIAN chapters hosted a mixture of events to help raise funds for the scholarship program listed above and other community programs while providing educational and networking opportunities for our members and other AT&T employees. Events include dinners, mixers, cultural events during special holidays such as Lunar New Year or Asian Heritage Month to encourage cultural enrichment of our Asian and non-Asian employees, lunch and learns featuring executive speakers, sessions on self development topics, silent auctions, cookbook, tee-shirt, chai tea and somosa sales, employee giving campaigns and donation requests. In addition to the scholarships and community doations, InspirAIAN also participates in backpack, food and Christmas toy drives for needy families.

4c (Code:) (Expenses \$ 28,577 including grants of \$ 5,000) (Revenue \$ 19,600)

Nine of the 13 InspirASIAN chapters participated in Dragon Boat Races in their local community. This activity is very popular because it allows our organization to educate Asians and non-Asians about the Dragon Boat culture while encouraging our members to exercise and practice as a team. Each team consists of 20 paddlers, a drummer to provide the paddling tempo, and a steerman who provides the team guidance for steering the boat. The team who crosses the finish line first wins the race and trophy. In many communities, the boat race is a fundraiser for the Dragon Boat Association or a community non-profit organization. InspirASIAN has been fortunate enough to have AT&T sponsr some of the events; AT&T uses the event for marketing purposes and allow the InspirASIAN teams to use the boats for the race.
