Some of them are top universities in China. To receive funding they first submit a grant application that explains the significance of the project, the key personnel responsible for execution, the time frame, and an itemized budget estimate. After a grant application is approved by PESi senior staff and/or committee made up of PESi staff, board members and outside advisors (most of the advisors have doctoral degree and understanding of education in Asia), funding will be sent by wire. The grant recipient will provide PESi with a formal receipt. When the project is completed, the recipient will send us a report (events such as conference) or sample publications (for publishing projects). The PESi president visits Asia 3-4 times a year to monitor the projects that PESi supports and meets with key professor who are responsible for the publications, conferences and seminars. He also keeps in touch with them via emails throughout the year. He serves on the board of Hong Kong Professional & Educational Services Ltd (HKPES), and communicates with other board members regularly in person and via emails. HKPES sends quarterly accounting statements to PESi. He also visits Bishkek, Kyrgyzstan 2-3 times a year. Serves as advisor to a Language & Culture Center and regularly communicates with the local director via emails. Annual detailed expense reports are submitted to PESi. The center also sends PESi their financial statements.
