THE FOUNDATION IS A PERMANENT CHARITABLE TRUST FUND ESTABLISHED UNDER THE WILL OF JASPER WHITING. THE FOUNDATION BEGAN AWARDED ANNUAL FELLOWSHIPS AFTER MRS. WHITING'S DEATH IN 1965. FOR THE FOUNDATION'S FISCAL YEAR ENDING 10/31/2019, THE TRUSTEES RECEIVED 95 APPLICATIONS AND MADE 40 AWARDS TOTALING \$209,146.99. ACCORDING TO MR. WHITING'S WILL, THE BENEFITS UNDER THE FOUNDATION ARE TO BE CONFERRED AT THE SOLE DISCRETION OF THE TRUSTEES BUT SHALL NOT AT ANY TIME BE DENIED FOR REASONS OF RACE, COLOR, NATIONALITY, RELIGION OR GENDER. ALL APPLICANTS MUST SUBMIT THEIR PROPOSAL FOR THEIR PROJECT OR STUDY TO THE TRUSTEES WITHIN CERTAIN TIME DEADLINES EACH YEAR. IN AN AGREEMENT WITH THE IRS, THE TRUSTEES HAVE AGREED TO MAKE THE AWARDS DIRECTLY TO THE COLLEGE OR UNIVERSITY WITH WHICH THE APPLICANT IS AFFILIATED.
