Explanation: The organization believes it mailed Form 8868 during the month of February 2020 as the deadline to file was March 15, 2020. We are unsure as to why the form was not received by the IRS. We spoke with an IRS associate on 8/4/20 and he explained the best practice is to use certified mail to ensure delivery of the mail is received as proof of timely filing. We believe it was mailed however it was not certified mail. We believe we had a reasonable cause for late filing as we were under the assumption the IRS received the extension. Upon further inquiries with a tax preparer, it came to our attention that the IRS sends a receipt of confirmation that the extension was received and the organization is confirmed to file their return 6 months later. This promoted us to inquire and correspond with the IRS to ensure form 8868 Extension to File was received. As our organization has been impacted by COVID-19 given we have received less contributions in the past few months, the IRS associate stated the IRS was also impacted and has delayed sending notifications of late filings. As of 8/4/2020, we were under the assumption that the IRS received form 8868 and we have not received a late filing notification. This was a year of transition for our organization and a new treasurer volunteered to assist in maintaining the records. As such, we believe we have reasonable cause for late filling. Our organization is ran completely by volunteers and relies heavily on volunteers to provide clothing to children.
