SPECIAL EVENTS INCLUDED KENTUCKY READS "ALL THE KING'S MEN" PUBLIC DISCUSSIONS, CHOCTAW ACADEMY BUILDING RESTORATION, SMITHSONIAN HOMETOWN TEAMS TRAVELING EXHIBITION, AND MINI-GRANTS TO FUND GRASSROOTS PROGRAMS. THE COUNCIL CONTINUED WITH THE MEDIA PROGRAM "THINK HUMANITIES", PRODUCING 45 PODCASTS AND 132 THINK HISTORY. THROUGH SPECIAL PROGRAMMING WE REACHED 647,769 PEOPLE.
