The Consortium follows the recognition requirements for uncertain income tax positions as required by the FASB ASC 740-10. Income tax benefits are recognized for income tax positions taken or expected to be taken in a tax return, only when it is determined that the income tax position will more-likely-than-not be sustained upon examination by taxing authorities. The Consortium has analyzed tax positions taken for filing with the Internal Revenue Service and state jurisdiction where it operates. The Consortium believes that income tax filing positions will be sustained upon examination and does not anticipate any adjustments that would result in a material adverse effect on the Consortium's financial condition, results of operations, or cash flows. Accordingly, the Consortium has not recorded any reserves, or related accruals for interest and penalties for uncertain income tax positions at October 31, 2019. The Consortium is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress for any open tax periods. |
