Medical supplies have been depleted and must be repurchased. The league's field paint machine is no longer functional, and fields are currently maintained with leased machinery.

PART III: The organization's primary exempt purpose is to instruct children in the game of soccer and promote player development, while emphasizing character-building qualities such as integrity, respect, responsibility, leadership, confidence, and positive sportsmanship.
