PARTICIPANTS, RECRUITED BY THE HOST ORGANIZATIONS, ATTEND THE PROGRAMS FOR FREE. HNY'S PROGRAM OFFICER REVIEWS ALL APPLICATIONS, AND ALL THAT DEMONSTRATE THE ABILITY TO ATTRACT AN AUDIENCE AND HOST THE PROGRAM SUCCESSFULLY ARE AWARDED, SO LONG AS FUNDING PERMITS.
