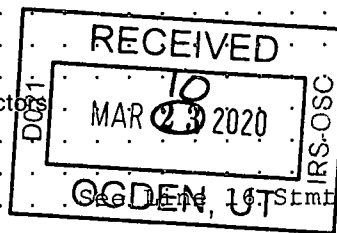

How agriculture contributes to the lifestyles of people throughout the world is also presented.
