In addition, students learn to build custom guitars and ukuleles through the community luthier program. The program also provides scholarship opportunities for those students desiring to continue their education in the arts.

The americana song academy is a teaching camp held over four days immediately preceding the sisters folk festival at the performing arts camp "caldera" on the edge of blue lake in the cascade mountains just outside of Sisters, Oregon.
