

"American Elegance/Wings and Wheels Event" - This event took place during Father's Day Weekend and captured early 1900s American automobile design and history through a unique living history program. A collection of over 70 automobiles, carriages, racecars, military equipment and airplanes was viewed by many members of the general public. The Foundation offered flights in a restored WWII Stearman bi-plane.

4b (Code \_\_\_\_\_) (Expenses \$ 441,777. including grants of \$ \_\_\_\_\_) (Revenue \$ 356,054.)  
The American Heritage Museum was opened to the public. This facility houses one of the world's largest collections of armored vehicles and tanks, all displayed in unique dioramas and displays. The museum includes exhibits covering from the Revolutionary War right up to current times. A gift shop is also available for the public to purchase items which promote the Organization's mission and American history.

"Battle of the Airfield" - The Foundation hosted this event over Columbus Day Weekend, during which approximately 350 volunteer "re-enactors" worked to recreate for many members of the general public a battle from World War II, as well as the conditions under which the participants lived and fought.
