4a (Code:) (Expenses \$ 230,420 including grants of \$ 0) (Revenue \$ 146,392)
South Park baseball continued to flourish in FY 2018. We had approximately 600 boys & girls participate during our Spring and Fall leagues, which encompassed t-ball (ages 4 & 5), rookie coach pitch (ages 5 & 6), coach pitch (ages 7 & 8), minors (ages 9 & 10), majors (ages 11 & 12) and babe ruth (ages 13 & 14). In addition to the revenues noted above, baseball received approximately \$39,200 of contributions from companies and individuals to help finance our program. All baseball coaches are volunteer parents who receive no compensation for their efforts. SPYA policy mandates that all coaches pass a background check on an annual basis in order to coach. Baseball teams are selected (drafted) each season subsequent to all players attending a skills day assessment, which helps ensure that our teams are as even as possible and creates fair competition. Some participants received partial or full financial aid to cover registration fees.

4b (Code:) (Expenses \$ 90,894 including grants of \$ 0) (Revenue \$ 101,973)
South Park lacrosse had another strong year in FY 2018, with approximately 325 boys & girls participating in the program. During the year, in addition to the regular programs, we also partnered with US Lacrosse to offer the TryLAX program, which provided an opportunity for very young athletes to spend a couple of days exploring the game. In addition to the revenues noted above, lacrosse received \$550 of contributions from companies and individuals to help finance our program. Coaches for SPYA lacrosse teams included volunteer parents as well as individuals with college / pro experience who receive a nominal amount of pay for the coaching activities. SPYA policy mandates that all coaches pass an annual background check in order to coach. Some participants received partial or full financial aid to cover registration fees.

4c (Code:) (Expenses \$ 48,860 including grants of \$ 0) (Revenue \$ 35,038)
South Park football continued to battle the national trend of fewer childrens playing the game of football. With that being said, our participation numbers were relatively flat from the prior year, remaining at approximately 100 players, which allowed us to once again field 4 teams. Our football league was once again aligned with Pop Warner youth football, which requires kids to participate based on age and weight restrictions to help ensure their safety. All coaches are required to complete an annual course on "heads up" football in order to ensure they are teaching proper techniques to the players. In addition, all football coaches are volunteer parents who receive no compensation for their efforts. SPYA policy mandates that all coaches pass an annual background check in order to be eligible to coach. Some participants received partial or full financial aid to cover registration fees. Finally, in addition to the revenues noted above, football receive approximately \$7,600 of contributions from companies and individuals to help finance the program.
