Finally, a thorough review is completed and the following services are provided:- Assist patients with a governmental assistance application when applicable.- Help patients determine if a third party is liable.- Provide medical services at reduced rates or at no cost.- Provide individualized plans based on the patient's ability to pay.- Use fair and consistent collection practices.
Part VI, Line 4 - Community Information	JENNINGS, is a small town of approximately 10,400 located on Interstate 10 about halfway between two major cities in Louisiana, Lafayette and Lake Charles. It is also halfway between Houston Texas and New Orleans Louisiana. Jennings is the seat of Jefferson Davis Parish. Jennings American Legion Hospital primarily services patients from Allen and Jefferson Davis parishes. Approximately 57,000 people reside in these two parishes. Residents in these parishes are primarily between the ages of 15 and 44, as this group makes up 39% of the population. Total population in these parishes are expected to decline slightly over the next two years. The average median household income in these parishes is approximately \$41,500, compared to \$46,700 for the state of Louisiana and \$57,600 for the United States.
