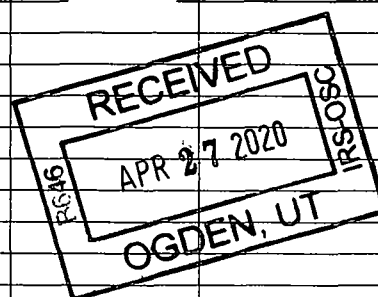

- (iii) Purpose of Grant: To establish a workshop to provide prosthetic limbs at Gondar University Hospital, in Gondar, Ethiopia. This hospital has 518 beds and serves a population of about five million people, and is open to the general public.
- (iv) Amounts expended by Grantee: No grant funds have yet been spent by Grantee as of June 30, 2019, the close of Grantee's fiscal year.
- (v) Dates of Reports: As provided in the Grant Agreement, Grantee submitted a timely report on August 31, 2019, which covers the period through the end of Grantee's fiscal year (June 30, 2019).
- (vi) Activity Reported by Grantee: Grantee's report stated that for the Grantee's financial year ended June 30, 2019 the following activities connected to this project have been carried out.
 1. Following a number of communications, a representative of Grantee travelled to Ethiopia to meet with the hospital staff between February 24 and March 1, 2019, and met with Rotary leaders and representatives of the International Committee of the Red Cross (ICRC) in Ethiopia and held detailed discussions with the senior management and medical staff of Gondar Hospital. These discussions covered all aspects of the project particularly staffing, material sourcing and the location of and building specification required for the proposed workshop.
 2. The discussions held with the leadership of the ICRC in Ethiopia concerned the possibility of a collaboration in order to use the ICRC prosthetic technology already in use in the country. Although these discussions continued after the visit, Grantee decided not to proceed with this idea based on cost and continued sustainability issues.
 3. Grantee is working with Gondar University Hospital to formulate a plan for the ongoing sustainability of the project once the initial stock of materials has been exhausted.
 4. Grantee has received specific commitments from two Rotary clubs for financial support and several others have expressed interest. Contact with these clubs is being maintained until Grantee has resolved the sustainability question mentioned in 3 above.
 5. Grantee confirms that no funds from the WAMJ grant have yet been spent. The expenses connected to the visit to Ethiopia earlier this year were paid from general funds of Grantee. As a result, Grantee has confirmed that:
 - a. No grant funds have been used, directly or indirectly, to carry on propaganda, or to,
 - b. attempt to influence legislation or the outcome of any election, or to carry on a voter registration drive.
 - c. No grant funds have been used to carry on any activity for a non-charitable purpose, or to make grants to individuals for travel or study.
 - d. Grant funds have not been re-granted to another organization.
 - e. Grant funds have been spent solely for the charitable purposes of the grant.
 - f. To Grantee's knowledge, grant funds have not, and are not, being used for purposes other than the grant described above, or misappropriated.
- (vii) Diversions: To the knowledge of the grantor, no funds have been diverted to any activity other than the activity for which the grant was originally made.
- (viii) Verification: The grantor has no reason to doubt the accuracy or reliability of reports from the grantee. If there are any doubts as to the accuracy or reliability of reports, verification will be made.

Compliance with Expenditure Responsibility Requirements

As part of the Expenditure Responsibility procedure, WAMJ Foundation has 1) conducted a pre-grant inquiry and 2) obtained a signed agreement from Grantee, prior to distribution of funds, which includes the following provisions:

- 1 Grant funds must be spent solely for the charitable purposes of the grant.
- 2 Grant funds may not be used, directly or indirectly, to carry on propaganda, to attempt to influence legislation or the outcome of any election, to carry on a voter registration drive, to carry on any activity for a non-charitable purpose, or to make grants to individuals for travel or study. However, expenditures for staff training of \$5,000 and trustee visits of \$6,000 shown in budget, are permitted. Funds from WAMJ may not be spent on the \$15,000 TATCOT course.
