If a conflict of interest is identified, the officers of the Board decide what action needs to be taken. Actions range from abstaining from certain Board discussions/actions/votes to action which require that a Board member resign. In the course of the year, if a Board member identifies that s/he has a potential conflict of interest or is identified as such by another Board member, the officers of the Board decide what action needs to be taken.

Part VI, Section B, 15 - After an in-depth exploration of the salaries paid to library staff at similar sized libraries in Maine, the Personnel Committee has developed a salary scale based on prior experience and years employed. The salary scale is reviewed on an annual basis with special consideration regarding an annual cost of living increase.

Part VI, Section C, 19 - When a person joins the Board of Directors, they are given an orientation by the selected Board members and staff. At that time they receive a full written packet of library policies, Board policies and other relevant information. These policies are reviewed annually by the appropriate Board committee and, if it is recommended that a policy be changed, the policy change is reviewed and approved or rejected by a full Board vote. Financial reports, program updates and committee reports are distributed at Board meetings and discussed by Board members. Policies, program reports and certain financial reports are available to the general public.
