IN ORDER FOR MRC TO FULFILL ITS MISSION OF OBTAINING ENVIRONMENTALLY SOUND AND AFFORDABLE DISPOSAL OF MUNICIPAL SOLID WASTE FOR ITS MEMBERS, IT SPONSORED THE DEVELOPMENT OF A NEW FACILITY TO MANAGE THE MUNICIPAL SOLID WASTE ORIGINATING WITHIN ITS MEMBER MUNICIPALITIES.
