

4a (Code: ) (Expenses \$ 84,672 including grants of \$ 0) (Revenue \$ 0) Support for Park Activities: We expanded our Baxter Youth Conservation Corps by 50%, from four weeks to six weeks. This program hires local youth to work on trail maintenance projects in Baxter State Park. Our 20 youth participants and 4 adult crew leaders completed 2,892 hours of trail work in and around Baxter State Park. We also began a new partnership that allows our Patten-based crew to spend a week working in Katahdin Woods & Waters National Monument. Our crews built 250 feet of new bog bridging near Kidney Pond, completed over 12 miles of corridor definition, installed 90 step stones, including 31 on the Hunt Trail on Katahdin, and demolished and rebuilt a 50-foot wooden vehicle bridge.

4b (Code: ) (Expenses \$ 54,614 including grants of \$ 0) (Revenue \$ 3,663) Education and Outreach: We offered the 11th annual Maine Youth Wilderness Leadership Program, which enables ten Maine high school students to experience a nine-day leadership training program in spectacular wilderness. Participants in this program learn from specialists in science, art, storytelling, Native culture, writing, history, and recreation. The goal of this program is to inspire and cultivate the next generation of Maine's environmental leaders. Other Education and Outreach activities include publishing our quarterly newsletter (5,200 copies distributed annually), publication of the 2020 Baxter State Park calendar, hosting four trips to Baxter State Park, and offering educational talks and displays at four public events.

4c (Code: ) (Expenses \$ 12,105 including grants of \$ 0) (Revenue \$ 0) Advocacy for the Park: We attended one hearing and one work session held by the Maine Legislature's Joint Standing Committee on Agriculture, Conservation, and Forestry. We attended five meetings of the Baxter State Park Authority, five meetings of the Katahdin Collaborative, one management planning meeting for Katahdin Woods & Waters National Monument, one public hearing held by the Land Use Planning Commission, and three meetings of the Appalachian Trail Task Force. We funded distribution of brochures and outreach materials through the Maine Tourism Association.
