THESE INCLUDED HOME VISITS WHERE NATIONALS ARE PRAYED FOR AND ENCOURAGED. THE AFTER-SCHOOL PROGRAM FOR HOMEWORK AND SOCIAL-SKILL DEVELOPMENT HELPED THOSE WHO ARE AT RISK AND PHYSICALLY CHALLENGED.
