The Children's Nutrition Education & Physical Activity Expo is a year round outreach program providing onsite services at community health fairs and after school programs. C.H.O.I.C.E.S. participated in 29 events reaching 3,045 children and adults. The Let's Move DeKalb Back To School Expo event is held annually to provide nutrition education, health information and school supplies to families. C.H.O.I.C.E.S. provided 1,500 people with 30,000 pounds of food and gave 1,050 children backpacks filled with school supplies.

Community Teaching Kitchen is currently under renovation and projected to open in the Spring of 2019. The primary purpose of the kitchen is to be a hub for community health education using cooking classes and educational workshops. The secondary purpose of the kitchen is to be a resource for other health minded non-profit organizations in Metropolitan Atlanta.
