2. The Foundation grants monies to the Special Education Departments at the two local High Schools to defer the cost of their Spring Learning Trip. All monies are used to benefit students directly. We do this because these students generally demonstrate love of learning and hard work, but would not qualify for one of our traditional scholarships.

3. The Foundation, with the help of the Elementary and Junior High Schools, grant monies to recognize elementary age students who demonstrate love of learning, hard work or commitment to community. We believe that students who demonstrate these characteristics at a young age will become candidates for scholarships when they are in High School.
